Tax Reform

Last Thursday, Senate Republicans released their version of tax reform; "Tax Cuts and Jobs Act." Unlike the House bill, H.R. 1, the Tax Cuts and Jobs Act, which was introduced a week prior – the Senate version did not include the elimination of the medical expense deduction, nor did it eliminate nonprofit health care entities' ability to access low-cost capital financing through tax-exempt private activity bonds.

House Appropriations Committee

11/15 at 9:30am: Military

While both the House and Senate original tax reform drafts did not contain the repeal of the Affordable Care Act's individual mandate, there was a steady push to do so by the White House. With the increased pressure, the Senate indicated today that the provision was being added to their version and the House is looking to possibly add it to their H.R. 1 as well.

The House is planning to vote and pass tax reform this week, while the Senate Finance Committee continues their mark-up and is planning to vote next week.

ADMINISTRATION

CMS Medicaid Announcement

Last Tuesday, the Centers for Medicare and Medicaid Services (CMS) Administrator, Seema Verma, made an <u>announcement</u> on the future of Medicaid. The agency says the new policies will "encourage states to propose innovative Medicaid reforms, reduce federal regulatory burdens, increase efficiency, and promote transparency and accountability. In addition, their new efforts would streamline and improve the 1115 demonstration, state plan amendments, and 1915 waiver processes.

Trump Nominates Alex Azar to Lead HHS

Yesterday, President Trump nominated Alex Azar as the next Secretary of Health and Human Services. Azar previous worked at Eli Lilly and in the George W. Bush administration. Several Senate democrats have already voiced their concerns with the nomination.
